

## A CIVIL WAR MYSTERY CONTINUES TO UNFOLD WILLIAM NEWBY OR DANIEL BENTON?

When William Kennann retired from his job as a computer programmer with McDonnell-Douglas Aircraft two years ago, he finally got around to reading a book that had been in his family for nearly a century. Before he finished it, however, he knew he had to republish it.

The book was about his great-grandfather, but the story it told was not everyday family history. First published in 1893, William Newby or the Soldier's Return is an account of one of the strangest cases of confused identity in the history of American jurisprudence. It is also a unique footnote to the history of the Civil War.

Authored by Gilbert Jasper George, the book tells the story of a soldier who returned to his home and family nearly thirty years after he was listed among the dead in a famous Civil War battle. Subsequently accused of fraud and imposture, he became the focus of a sensational trial that drew national attention in 1893.

William Newby, an Illinois farmer, had enlisted in a Union infantry regiment soon after the Civil War broke out. In a fierce exchange at the battle of Shiloh, he suffered a serious head wound and was left behind when the rest of his company retreated under heavy enemy fire. The Union forces regained their lost ground two days later, and Newby was listed among the dead who were buried in a mass grave at the battle site.

Nearly thirty years later, however, a veteran from the same regiment met a bearded, bedraggled wanderer in the town of McLeansboro, Illinois. Convinced that the stranger was his fallen comrade, he alerted Newby's kin in nearby Mill Shoals.

At first suspicious, Newby's family soon recognized and accepted the stranger as their long-lost relative. From his disjointed stories and bits of corroborating evidence, they pieced together an almost incredible story. Severely but not fatally wounded at Shiloh, he had been captured by the rebels and spent the rest of the war in a succession of prison camps, including the infamous stockade at Andersonville, Georgia.

Because his memory had been damaged by the wound to his head, he failed to be repatriated after Appomattox. For nearly three decades, he tramped around the country until fate delivered him to his home county.

When he first returned home he remembered little of his former life, but in time, his memory improved and he began to recall family history and other events that helped prove his identity. He also bore several scars and birthmarks that his relatives remembered from before the war.

When accounts of his long-ordeal and miraculous homecoming appeared in newspapers around the country, the Newbys were flooded with mail and besieged by vistors who wanted to see theman who had returned from the dead.

But the opinion of family, friends and neighbors as to his identity was not shared by everyone. When he applied for an army discharge and a veterans pension, the man who now called himself Newby was jailed and indicted on charges of fraud and impersonation. The government claimed he was a "Tennessee adventurer" named Daniel Benton, alias "Rickety Dan."

In a dramatic trial held in Springfield, Illinois in the summer of 1893, 140 witnesses swore the defendant was William Newby of Illinois; thirty others testified that he was Daniel Benton of Tennessee; and a half-dozen maintained that they had known him as "Crazy Jack", a half demented inmate at Andersonville prison.

After deliberating for only twenty minutes, the jury delivered a guilty verdict that stunned the entire city. A month later, the defendant was sentenced to two years hard labor in the federal prison at Chester, Illinois.

After the trial, Newby's supporters raised money to take the case to the Supreme Court, but their attempt failed on a technicality.

G. J. George, who authored the book on Newby in the wake of the trial, was a staunch member of the Grand Army of the Republic. He had served as an officer in Newby's company and had seen him fall at Shiloh. Despite the fact that he had signed reports listing Newby among the dead after the battle, he was later convinced that the man who returned in 1891 was genuine. George believed that his former comrade had been grievously wronged by the government.

His opinion is shared by some historians today. Paul Stallings, of Fairfield, Illinois, has studied the case for many years and contends that Newby was railroaded into jail because the pension board was reluctant to pay out thirty years worth of back pay and veterans benefits. He also suggests that the trial was flawed by unduly influenced witnesses, a biased judge, and a rigged jury.

That's part of the reason William Kennann decided to reissue the book. "It will be interesting to see if new information surfaces as more people have the opportunity to study the case," he said. "All of Newby's children were born before he went off to war, so that's not an issue. But it would be good to know once and for all whether the man who returned thirty years later was really him."

George's book went out of print before the turn of the century and has become a collector's item. Original copies are virtually unobtainable. In the new edition, Kennann Publications has added an update Foreword and Epilogue, a complete index and previously unpublished documents from National Archives' records of the case. The title has also undergone a minor revision: it's now called "William Newby: A Civil War Soldier's Return".

"To talk to some people you wouldn't know it," said Kennann "but there have been several wars since 1865. We added "Civil War" to the title to make sure people know which one this book is about."

Kennann is hoping to hear from other relatives of William Newby. "He was born in Smith County, Tennessee." he said. "His parents lived there before they brought him to southern Illinois as a boy. He was descended from two families--the Newbys and the Simpsons--both originally from Virginia. The Simpson side of the equation has been pretty well explored. I'd like to know more about the early history of the Newby side."



RESOLUTIONS-Of the Fayetteville Bar on the death of Gen. R. Farquarson. At a meeting on Sep. 28, 1869, the Hon. J. P. Steele was requested to act as chairman & George B. Boyles as second. The object of the meeting being explained, Messrs. John M. Bright, J. H. Burnham & James W. Newman were on motion appointed a committee to draw up resolutions expressive of the sense of the meeting viz:

It has become our painful duty to announce that on 26th inst. at his residence in this place, Gen. R. Farquarson, Clerk & Master of this court, departed this life. A brief biographical statistics must suffice for the present. He was born on the 14th Sept. 1813 in the County of Bauffin in the North of Scotland; in 1827 he immigrated to the U.S.; resided a few yrs. in Nashville & about the month of May of 1830, he located in Fayetteville, which place he made his home until death. His first employment was as a clerk in merchantile house of Wm. Akin & Co. Afterwards became a merchant & conducted a house for several years with success. He was successively elected Major, Colonel & Major General of Militia in which he took great pride. In 1839 he was elected a Representative from Lincoln Co., to the Popular Brauch of our State Legislature. In 1846 he volunteered for a 12 mos. service in the Mexican War, was elected Major of the 1st Tenn. Regt, of which Gen. Wm. B. Campbell was elected Col. While leading a detachment of 2nd Tenn. Regt. in storming the heights of Cero Gordo, he was severly wounded. He returned home in 1847, worn down & enfeebled with disease & wounds. He was appointed Clerk & Master of the Chancery Court at this place in 184 . In 1849 he organized a company & went overland route to California in search of gold. In early part of 1851 he returned & same year was elected a Representative of the Popular Brauch of our State Legislature. In 1853, President Pierce appointed him Secretary of Washington Territory on the Pacific. His appointment was confirmed by the Senate but he refused to accept. In 1852 he was elected State Senator from Countys of Lincoln & Franklin. In 1854 He was appointed Clerk & Master of this County, as the successor of Col. John S. Fulton, continuing in office until fall of 1861 & through the recent war. In fall of 1861 he volunteered in the Southern cause & was elected Colonel of 41st Tenn. Regt. in which he served with gallantry. On his return at close of the war, he was appointed Clerk & Master of the Chancery Court by his Honor, Chancellor Steele & continued in the office until his death. I, Resolved - that we the members of the Fayetteville Bar tender to the widow & family of the deceased and to the citizens of Lincoln Co., our condolence in their bereavement.

REEVES-LEGATE FAMILY of Obion County, Tennessee - Submitted by Bill Legate,

Among Reeves families who came from South Carolina to Obion Co, Tennessee is a William D. Reeves who secured bond for the 1842 marriage of Jefferson Legate. William married Susannah Garrison in 1845 in Obion Co. In 1859 they wrote a letter describing a scarlet fever epidemic in their county. It was written to John Tarpley Reed LEGATE, William D. Reeves' brother-in-law. J.T.R. Legate was born in 1818 in Williamson Co, TN, and died 15 Mar 1871 in Randolph Co, AR. He was probably a nephew of Jefferson Legate. At the time of the letter, J.T.R. Legate lived seven miles south of Vienna in Johnson Co, Illinois, and the Reeves lived in the vicinity of Troy, Tennessee.

"State of Tennessee 1859 Obion County Feb the 25

Dear brother and sister I take the time to inform you that we are all getting well a gain John when I landed home I found my family very sick with the scarlet fever I thought for some time that we would loss too of our children our youngist child has lay now twenty seven days and aint out of danger yet every won had it the balance of our connection are all well at this time hopeing these linse will find you all well John I hope you will pardon me for not writeing to you sooner I had nothing much to rite to you ther has been some deaths out sid off your knollage and a goodeale off sickness John I have done but one days work since I cam hom on the account off sickness I want you to rite soon and give me the times I remain yours

This land matter you can have for eight hundred and fifty dollars pay what you can down the balance in one or too years

MAGINLEY-CARROLL, CIRCUS FAMILIES - Contibuted by Rhoda Glenn Halm

In the season of 1862-63, Benjamin Rush Maginley, an actor, clown and sometimes circus owner, was contracted to manage a Memphis, Tennessee theater.

William "Barney" Carroll was a 4-horse Roman rider and part owner of circuses. His adopted daughter, Mary, was a leopard trainer and bare-back rider, whose stage name was Mlle Marie Elise. They, too, arrived in Memphis in 1862 with the Madigan & Carroll Circus. On January 3, 1864, Benjamin Maginley and Mary Carroll were married by Lewis R. Richards, J.P. Their daughter Mary Josephine was born in Memphis November 5, 1864. There were two other daughters, who died young, Nola Eugenia and Viola Alberta. Date and place of their birth unknown.

William Barney Carroll was born in Knoxville, Tennessee on March 13, 1816. In 1840 he married Mary Ann Sprague, who was the aunt of his adopted daughter, Mary. W. B. Carroll died in Westchester, NY July 14, 1889.

Benjamin Rush Maginley was born in Pennsylvania on November 18, 1832 and died in Westchester Village, NY on June 3, 1888.

Mary Ann Carroll Maginley was born November 12, 1844 in New York and died there August 18, 1874. Their dau. Mary Josephine, died in Shanghai, China April 12, 1939.

Information may be found in the most unlikely places! While organizing the marriage licenses for filing at the archives, volunteers found an unusual notation on the reverse of the license for George W. SPINKS and "Miss" Annie Virginia BEAM issued 26 Oct 1874, solemnizer Nov 1874 by S. B. SURATT, M.G.). The data found follows.

Mrs. A. V. Beam, maiden name HAMILTON, born in VA, married twice, age 26 years, Memphis resident.

S. W. Spinks, born in VA, age 30 years, occupation carpenter, resides in Memphis, has been married once.

Another license was issued to John SCHULTZ and Miss M. E. JACKSON (issued 30 Aug 1875, solemnized by P. McHAWARD 3 Sep 1875). On the reverse is written "Jno Schultz Son of Joseph Schultz & Kate VAUGHN, E. E. <u>Peterson</u> Jackson & Elizabeth BOLAND. Witnesses Benjamin L BURCH & Florence WASHINGTON."

## SAMUEL SCOTT'S ESTATE SETTLEMENT - Memphis & Shelby County Archives 33 S. Front St., Memphis, TN 38103

The Shelby County Tenn. County Court Minute book records various events of genealogical interest, and the proceedings during the Civil War and Reconstruction Years are revealing as well as genealogically interesting. Although the city of Memphis was occupied and under Federal control during and immediately after the war, the county seat was in Raleigh (not part of Memphis) and the court met there to carry on business.

In June of 1867 the County Court Minutes (Vol.15) recorded that an inventory of the estate of H. A. Cordes, dec'd, was returned by A. Cordes, Admr. and that J. B. Stark, J. H. Choate and J. H. Wallace were appointed to set apart to Caroline Thompson, widow of Erastus G. Thompson, dec'd, her year's support.

But this immediate attention to current business was followed by on-going legal problems that were continued over the years. The estate of Samuel Scott who had died in 1848, was one of these.

Petitions for a final settlement of Samuel Scott's estate were filed by his descendants, or their spouses, and the final payments were made to Edward T. Scott, Germon F. Scott, John L. Scott, Mrs. A. J. Neal (now Easly), Mrs. V. T. Craig, Joseph/John B. James, husband of Sarah T. James, deceased, and his children Wm A, John T., George W., and Benjamin H. James.

Samuel Scott's 1848 will named a wife and two sons who had apparently died before 1867. The sons were William and Samuel W. Scott, who must have left no children to share the inheritance.

Early on, the 1867 lawsuit indicates that Amelia J. Scott, a daughter of Samuel Scott, married William H. Neal "now deceased". "Virginia T. Wright, (maiden name Virginia T. Scott), since the commencement of the suit, intermarried with one Craig, who has since died..." "Defendant Rebecca W. Scott has intermarried with one W. H. Craig..." "Rebecca Craig and German F. Scott are over twenty-one." "Amelia J. Neal has intermarried with one M. V. Easly"

Sales of Samuel Scott's estate, prior to 1867, mention W. C. Ward, W. H. Neal, S. W. Scott, C. Kortrecht, Wm. Lewis, A. D. Hunter, I. Bolton, Jr., Murrell, Walker, James, J. Neil, H. M. Blake, H. Read, A. G. Ward, E. Scott.

Claims against the estate were filed by E. T. Scott, Houze, I. B. James.
Samuel Scott had owned 434 A near Big Creek in Shelby Co, TN bounded north by
John Willis, east by Wade Bolton, south by A. D. Hunter, west by William Ward.

# MIGRATION PATHS INTO TENNESSEE

While reading queries published in the most recent edition of "Ansearchin'" News, I was compelled to write the following. Perhaps it will provide readers researching early settlers of middle and west Tennessee with insight into the origins of their previous generations.

Two areas of North Carolina were points of migration into Davidson and Rutherford Counties in middle Tennessee c1800.

The Rowan/Mecklenburg/Iredell Counties area of North Carolina provided Scotch-Irish immigrants: Campbells, Craigheads, Jacksons, Johnsons, Ewings, etc., and those families with close ties to the surveyors Rutherford and Weakley. Additionally, when the migration started into Williamson, Maury, and other southern counties of Tennessee and on into Northwest Alabama, one again finds the Mecklenburg group. Migration of this group from Williamson County into western Tennessee occurred c1830 when Henry Rutherford surveyed the area known as Key Corner and took many of his kinsmen with him to the Weakley County area.

The Johnston/Wayne/Old Dobbs Counties area of North Carolina provided Middle Tennessee immigrants whose ancestors generally started their migration from the Isle of Wight area of Virginia and proceeded along Green's Path into North Carolina. An 1810 census exists for Rutherford County, Tennessee and it mimics the 1800 census for Johnston and Wayne Counties, North Carolina. In fact, James Robertson, the founder of Nashville, has family ties to Johnston County. These Rutherford countians continued their migration west into the Hardeman County, Tennessee area when lands opened c1830.

A migration from Johnston/Wayne Counties, North Carolina again occurred into Tennessee c1830. This group settled in the Madison, Gibson and Hardeman Counties area and does not appear to have close ties to the immigrants of c1800.

Many of the Johnston/Wayne Counties records were destroyed by fire and research prior to c1760 is hampered. However, the Johnston County Room at Smithfield Public Library, Smithfield, North Carolina is well worth a visit.

The 1850 CENSUS is especially helpful in identifying families because it is the first to list all members of a household. This copy was extracted from microfilm and a print out of a roll of microfilm. The households are listed in the order in which they are found on the film which helps to place a family within their neighborhood. Barry Co was formed in 1835 from Greene Co, which was formed from Crawford Co in 1833. It is located in southwest Missouri on the Arkansas border.

These OBITUARIES taken from the weekly newspaper, <u>Berry County Advertiser</u>, were photocopied in chronological order. The collection covers the year 1990 except for the month of April. Those may be seen at the office of the Advertiser. Many details of the deceased's life are usually given. Obituaries of persons living to be 80 to 100 years old can bridge the gap between ancestors and descendants.

The state of North Carolina is indeed fortunate to have several excellent genealogists who transcribe and distribute its Colonial records. One of the most dedicated and prolific is Weynette Parks Haun. Her work is an accurate interpretation of ancient handwriting and obsolete phrases, and every extant word is transcribed, not abstracted. Her expertise is now extended to include two Virginia counties

Chowan County's miscellaneous papers, transcribed from microfilm from the North Carolina Department of Cultural Resources, cover a variety of local activities. Powers of attorney, wills, lists of tithables, jury lists, bonds, law suits, certificates for insolvents, estate divisions, and petitions for roads to be built, are some of the items included. Frequently, relationships are explained as children choose guardians or widows settle estates. A picture of life in the county can be developed from these papers which are filled with names of local citizens. Obsolete terms are explained by definitions from Ballentine's Law Dictionary.

Hillsborough District Superior Court Minutes were copied from material in the North Carolina Department of Archives and History in Raleigh. The district covered Caswell, Chatham, Granville, Randolph, Wake, and Orange counties. Court business ranged from fines for not attending court as a juror, to indictment and trial for murder. The names of many citizens are included as jurors, witnesses, bondsmen, and officials. Lists of petit and grand juries are included. This book is particularly important to Orange County, NC because its County Court Minutes 1767-1776 are missing.

The Johnston County land records were taken from loose land records filed in the Secretary of State's Collection in the North Carolina State Archives at Raleigh. The entry warrants include a description of the claim, names of neighbors and number of acres. Many are illustrated with small plats & maps. An inventory of entries lists names, number of acres, date of entry, and location of the land. Ancestors can be placed in the county from these entries.

<u>Sussex County, Virginia</u>, records were taken from the Court Order Book, 1754-1801 in the county courthouse. The proceedings of this court reveal the lives of the citizens of the county through wills, lists of tithables, jury lists, inventories of estates, and disputes over debts. Many citizens are named and some relationships are given in estate settlements and guardianships. Black's Law Dictionary was used for explaining unfamiliar terms.

<u>Surry County, Virginia Court Records</u>, is the seventh of a series which began with an Order Book dated 1691-1713. Wills, estate settlements, road maintainance, and deeds of sale are some of the areas covered. Jury lists are given. Many citizens are named with relationships explained. Mrs. Haun's Book VIII, will begin with records of 1741; the records from 1719-1741 are missing.

A family committee completed the work begun over 40 years ago by Dick Cathey, who had published a newsletter for the Cathey family. The family history is traced from Scotland to Northern Ireland then to America. Based on over 12,000 individual records, this volume relates the family history and describes the events which touched their lives. The book is illustrated with photographs, maps, and documents related to the family. The Appendices contain lists of descendants of individual families. More volumes are planned.

Established before Tennessee achieved statehood, Bethesda United Methodist Church celebrated its bicentennial with the issue of this volume. Rev. Stephen Brooks, who is considered the founder of the church, was also a delegate from Greene County to help write the state constitution. Family history is covered as well as church history. Family history is covered in ancestor charts and individual sections, illustrated with photographs. A list of all known graves, with a plat, is given for adjoining Harrison's Cemetery.

Formed in 1834, Choctaw County was named for the Indians who ceded the land in the Treaty of Dancing Rabbit Creek. Portions of the County were taken to make Montgomery County and later Sumner County, present day Webster County. Courthouse fires destroyed many early records. The first Deed Book survived and is located at the Mississippi Department of Archives and History at Jackson. Abstracts of this deed book give names of buyers and sellers, dates, type of property, names of witnesses, and any other names mentioned. Also at the state archives are microfilm of tax lists for 1835 and 1844 which are included. The first marriage book begins in 1882. Brides, grooms, dates, and bondsmen are listed. Wills up to 1900 are listed stating testators, date, and all persons mentioned with relationships, if given. This information provides a frame work with which to view early Choctaw County.
