We mourn the demise of the GENEALOGICAL NEWSLETTER, edited by Inez Waldenmaier of Washington, D. C. It filled a need not covered by other publications in this field -- it was truly unique!

We are pleased to add to our growing list of exchange editions THE COLORADO GENEALOGIST, edited by Bernice Fitzsimmons Hathaway, and a publication of the Colorado Genealogical Society of Denver. A bouquet to Texas -- an invitation was extended to the ten genealogical societies and other interested groups in Texas by the President of the Fort Worth Genealogical Society, Mrs. Edna Perry Deckler, to attend the organiza-

tional meeting of the Texas State Genealogical Society held November 28, 1960 in Fort Worth. We were pleased to note that one of their resolutions read, "We desire to hold annual institutions of genealogical research, to organize societies in cities where there are now none, to publish a quarterly of high scholastic standards, to prevent duplication of works of various groups, to exchange ancestral charts, and to cooperate with all existing genealogical, historical, and patriotic groups ---." Texas is very genealogy conscious and the fact that their history is so closely allied with that of Tennessee makes us wish for such an organization the best of luck in reaching their goals.

TOOLS FOR RESEARCH:

In reply to our questionnaire about whether or not to continue this part of the publication, Mrs. J. C. Wax, 108 South 7th St., Amory, Mississippi, writes, "You often wonder if anyone is interested in this department of 'Tools for Research'. I was amazed to find such good response and to know libraries, book stores, etc. did want such items in their collections." Last year we mentioned the "Complete Index of All Wills & Estate Settlements or Administrations" in the court house at Pontotoc, Mississippi for the years 1836-70 which are available from Mrs. Wax for the nominal fee of \$3.90 and the response brought the above letter. (By the way, she still has a few copies which she will mail the same day the order is received.)

Searchers using the Memphis Public Library will be delighted with the newest addition to the census microfilm. Mrs. E. Hope Brooks, Librarian, reports that since 1958 the Memphis Genealogical Society, in cooperation with the Memphis Public Library, has placed a total of 226 rolls of film on file at a cost of one thousand four hundred sixty nine dollars. POTPOURRI - genealogical tidbits gathered from here and there.

You never know where you will find the answer and this is certainly true according to a note from Miss Lucille Payne, Box 47, Olive Branch, Mississippi.

"Each time I have studied all the marriage records (Shelby County, Tennessee Marriage Bonds). My parents knew most of the older families in Whitehaven, Capleville and many in Memphis. I like to see familiar family names, then I can wonder what happened to the families I have not heard about. Thus I accidently found the marriage of one of my great-great uncles under the medieval spelling 'Pagan' for Payne. I had wondered why this marriage was not recorded in DeSoto County records.

The marriage bond number is 32 - Pagan, Edwin A. to Martha J. Blocker, Jan. 18, 1848, Wm. A. Crutcher, Sec., B. S. Fant, M. G.

This old spelling must have been in the record, for that is one of the old spellings for Payne. The word 'pagan' meant unbaptized infant."

(Dickins) Hicks, who were sisters-in-law; also first cousins, their mothers being Elizabeth and Nancy Pulliam, daughters of John and Elizabeth (Wilson) Pulliam.

"Benjamin Pulliam & his wife, Mary Bruce, & Jno. Wilson & his wife Mary Israel are all entombed in Blue Stone church yard of Mecklenburg County, Va."

"My husband's grandfather John Pulliam, senior & his grandmother Elizabeth Wilson & his Uncle Barnett Pulliam, Jr., are all entombed in the Family Burial ground of my husband's great, great grandfather, Edward (George) Bruce in Granville County, N. C." /s/ Harriett Dickins

"Barnett Pulliam, Sr., survived his only brother, my husband's grandfather less than four years, he acted as guardian to his brother's children until his death and then bequeathed to them his whole estate; his remains were interred in the Bruce Burial ground near his brothers. Mary Pulliam (Mrs. Rose) was buried in Blue Stone church yard." /s/ H.D.

"Abel P. Upshur, the husband of Ann Wilson was killed by the explosion on board the ship Princeton, which occured at Washington City during the administration of President Tyler; it will be seen by reading a previous note that her mother, the 2nd wife of Thomas Wilson, lost her life in the Richmond Theatre when it burned in 1810." /s/ H. D.

"My eldest sister Ellen Webb married Robert Fisher Dickins, the 2nd son of Col. Sam'l Dickins. Sister Ellen and her husband both died a few years after their marriage. They left only one child, a son, Robert Fisher Dickins, who resides near Oxford, Mississippi." April 28, 1862 /s/ Harriet Dickins

"Gen. Stephen Moore, was once proprietor of West Point. He sold it to the United States & settled his beautiful family residence in Person Co., N. C. known as "Mount Tirzah". My husband's uncle-in-law was buried in the Moore Burial ground on "Mount Tirzah". His widow, Mrs. Portious Moore still resides at "Mount Tirzah." April 28, 1862 /s/ H.D.

"My husband's aunt, Mrs. Butler, still survives. She resides in Granville Co., N. C. She has a daughter, Mrs. Dr. Phillips who resides 25 miles from Grenada Miss. My husband's cousin Robert Pulliam, the youngest son of John Pulliam was last heard from, a clothing merchant in New York City." April 28, 1862 /s/ H.D.

"My grandfather Robert Dickins came from England as a partner in a London Mercantile Firm who had a branch of their house located in Norfolk, Va. His wife, Mary Brown was the daughter of an English Merchant, resident either in Norfolk or Petersburg, Va. After marriage he emigrated to N. C. He selected a home in Person Co. and marked the spot for the Family Burial ground; himself & wife are there entombed." /s/ Mary Hicks

"Peter Bland, only son of Richard & Elizabeth Bland was born in Notroway co., Va. He was a Presbyterian Minister; he moved to Tennessee in 1828 and continued to discharge the duties of his Holy Vocation until his death which occured in Haywood Co., Tenn. A. D. 1859

"My Uncle Jesse Dickins & his wife & Aunt Clack he entombed in the "Dickens Burial ground" in Person Co., N. C. Aunt Bland was buried in the Bland Burial ground in Nottoway Co., Va. Uncle Sam Dickins & his 1st wife he entombed at his residence where he died in Madison Co., Tenn.; his 2nd wife was buried in LaGrange, Tenn." /s/ Mary Hicks
