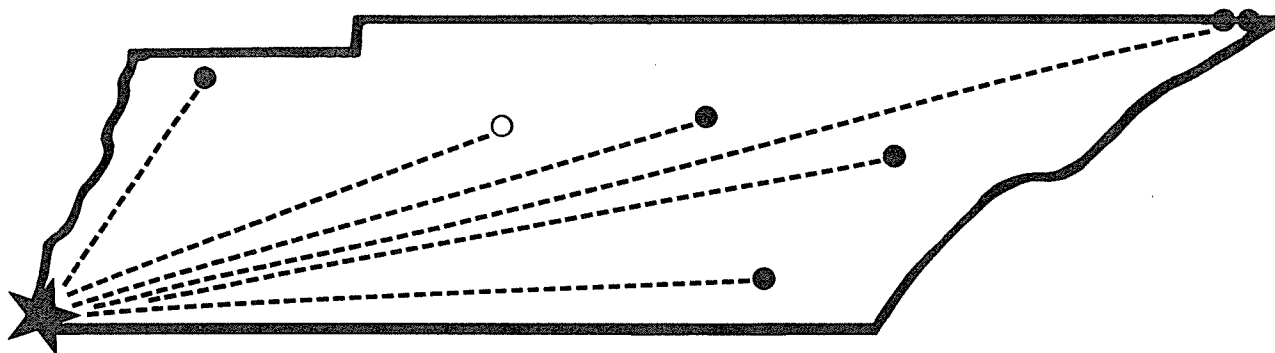

The Biographical and Historical Memoirs of Mississippi was published in 1891 by the Goodspeed Publishing Company. In 1978 it was reprinted by The Reprint Company, Publishers, Spartanburg, SC 29304.

The abstracted biographies show some connection with Tennessee in the life of the subject. Since they are abstracts and not complete quotes, the researcher should refer to the original book for complete information.

ABRAHAM HOSS YEAGER AUTOBIOGRAPHY - Contributed by Kathryn Yeager Walraven,
4609 Wilma, Corpus Christi, TX 78412

Abraham Hoss YEAGER published his 129-page autobiography in 1899 in Cleburne, Tx. It is titled, "Jacob Klodsloe, One of the Nobodies-How he came home from the war-How he grew up and into it." Why he used the penname Jacob Klodsloe is unknown.

Abraham, who was born in 1842 Washington Co TN, served in Company G of the 29th Regiment, Tennessee Infantry (Confederate). He enlisted in 1861 and fought in the battles of Corinth, Tupelo, Chickamauga, Missionary Ridge and Kenesaw Mountain where he was captured in March 1865. Following the war he taught school in Washington Co TN while studying law and then passed the Tennessee Bar. He practiced law two years before migrating to Texas in 1872. Abraham practiced law in Fort Worth for two years before moving to Johnson County to farm near Cleburne. In 1875 he purchased a half interest in the Cleburne Chronicle where he directed the editorial operations for six years. Later he was owner of the Cleburne Telegram and editor of the Cleburne Enterprise.

In 1890 he retired from his newspaper work to devote full time to improving his farm east of Cleburne. Abraham died in 1940 at the age of 98, still alert and reading without eyeglasses. The autobiography includes an account of his early life on the frontier in Eastern Tennessee with a perceptive feel for life in rural Tennessee prior to the Civil War and he also relates about life in the Union prison camp and the long trip home.

A.H. Yeager's ancestors were Alsatian Germans who landed in Virginia in 1717. Nicholas YAGER, who was born in 1678 Germany, emigrated to Virginia with his wife, Mary (WILHOIT) and children Adam and Mary. Adam, born 1707 and died 1794 Madison Co VA, married Susanna KOBLER and had a son Nicholas Yeager, 1735-81, who married Susanna Wilhoit. Among their sons were Solomon Yeager, born 1759 Culpeper Co VA and died 1851, married Elizabeth BROYLES; and Cornelius. Solomon's son Daniel, born c1781 and died 1837 Washington Co TN, and Cornelius' daughter Susannah were married. These first cousins were the parents of Abraham Hoss Yeager, who married Mary Vincent HIGHTOWER. They were the parents of Abraham Hightower Yeager (1887-1979), who married Ruth Irene SMYTH (1894-1987). Abraham and Ruth are Mrs. Walraven's parents.

FRENCH FAMILY BIBLES - Submitted by Jenny French LaMore,

The first Bible was owned by William James FRENCH and he passed it to his grandson, Aubrey Wade French, who is Mrs. LaMORE's father. The second Bible has some of the identical information. This French family lived in Western Tennessee, mostly in Stewart and Henry Counties, and Western Kentucky, mainly Graves Co.

"HIS NAME WAS ELKANAH" - Submitted by Royleta C. Malone, 1097 West Yarrow,

Elkanah ANDERSON was born about 1774 in North or South Carolina, the son of John Anderson. The Anderson family moved to Mercer County, Kentucky before 17 Jul 1798 when Elkanah's sister Mary (Polly) Anderson married Thomas WHITWELL; Elkanah was the bondsman. On 20 Sep 1798 Elkanah married Sarah (Sally) MURRY/MURRAY in Mercer County; Thomas Whitwell was the bondsman. On 26 Feb 1799 Elkanah was a witness when Robert Whitwell married Nancy Murry.

In July 1801 Elkanah Anderson entered 100 acres of land in Barren Co Kentucky. He was on the Barren County tax rolls from 1801 through 1806; in 1802 he was a constable in Barren County. While living in Barren Co Elkanah and Sarah had six daughters and one son. They moved to Dickson Co Tennessee about 1810 where Elkanah purchased land 19 Oct 1814. Two sons, one named Elkanah were born in Dickson County.

Family Gatherings (continued)

On 13 Nov 1814 Elkanah, along with his brother-in-law Thomas Whitwell and other Dickson Countians, enlisted in Capt. Francis ELLIS' Company of Cocke's 2nd Regiment of Tennessee Militia. They marched to New Orleans where they participated under General Andrew JACKSON in the battle with the British 8 Jan 1815. Elkanah was mortally wounded and died in New Orleans five days later. His widow Sarah Anderson gave birth to a daughter, Sarah Jane Anderson on 17 Apr 1815. On 21 May 1815 Sarah appointed Francis Ellis her Power of Attorney to get her husband's military pay. She was still trying for the pay on 3 Apr 1816.

Sarah Anderson was living in Dickson County in 1820 and 1823 when her daughter Margaret married Pleasant Whitwell. Her daughter Hannah married Cooper B. LAND in 1824. By 1830 Sarah, with her three youngest children, was living in Hickman Co TN next to her son-in-law Pleasant Whitwell and near her son John M. Anderson who had married Sarah Whitwell in 1825. John M. and Sarah named their first son, born 10 May 1827, Elkanah Anderson; he was called "Kane." In Hickman County 1835 Sarah's son Elkanah Anderson Jr. married Martha Jane SPURLOCK. Sarah also had a nephew named Elkanah Anderson, born 1815, the son of her sister Betsy Murray and John G. Anderson. He married Mariah DURNING 30 Mar 1837 but died in 1844.

In 1840 Sarah Anderson was living in Hickman County near her son Elkanah, her nephew Elkanah Anderson, and her grandson Elkanah Anderson. Her grandson Elkanah Anderson Land, born 28 Mar 1827, was the son of Cooper B. Land and Hannah Anderson Land. Sarah's niece Sarah Jane Anderson, daughter of John G. and Betsy Murray Anderson married Samuel BATES in 1825 in Hickman County, and they had a son named Elkanah Bates, born 1835, who married Mary Elizabeth Whitwell in 1857.

The name Elkanah was not carried down in any of these families, as far as is known. Elkanah Anderson Land became a well-known preacher in Perry Co TN, but was known as Rev. E.A. Land. Elkanah Bates is listed in the 1850 Hickman County census as "Caner" and in 1860 as E.C. Bates. Sarah Murray Anderson, who was born about 1779, died soon after 1840 and is probably buried in Hickman County.

CHARITY STANDEFER'S LETTERS AND MANUSCRIPTS - Contributed by Mrs. Maxine
Musselwhite, 3053 Manhattan, Memphis, TN 38112

About 1818 Luke STANDEFER along with his wife Mary Ann (PRICE), their children and slaves left Franklin Co VA and moved to Sequatchie Co TN near Mt. Airy where his brother William Standefer already lived. William was a Representative in Washington, D.C. and their brother James Standefer Jr. was a Representative from Hamilton County, Tennessee.

In five to ten years after immigrating to Tennessee, Luke and Mary Ann moved to Monroe Co MS. While the family lived in Tennessee they were connected with a Methodist School. This may account for the family tradition that their daughter Charity was a preacher and a missionary. The religious nature of her letters would confirm this.

Charity's surviving manuscripts and letters date from 1813 to 1826, which were written by Charity and her former classmates. The Old Standefer Meeting House in Sequatchie is mentioned often. Some of the names mentioned in the papers are: Judah, Judith, Kesiah, Sarah and William Standefer, John P. Blakeley, Mary Blakeley,

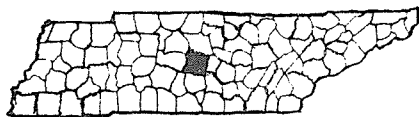

A 6-page letter written to the sisters Charity, Sarah and Kesiah from John P. Blakeley, Salem Post Office, W. Tennessee, Franklin Cty, August 17th 1826 reflects their religious fervor. "Dear Sisters in Christ, Having not forgotten the mutual promise we made each other before we parted, viz, to keep up a correspondence by letter; I again take up my pen...The last one I got was signed by sister Charity, dated October 27th 1822. A performance this, truly worthy of its author, with whom I have spent some very agreeable moments in years past, and with whom I hope to spend an eternity of superlative enjoyment beyond the boundaries of this present fluctuating scene. Another one dated December 26th 1821, signed by sister Sarah... I still preserve these two omens of respect as sacred, and read and reread them with great delight...Frequently in perusing these two excellent letters, my poor heart kindles into a flame, my eyes run over with tears of brotherly affection, while they call fresh to my recollection the many times we have met together in Christian consort...In 1823, the first year I lived here in Franklin...It would be truly gratifying to me to keep up a religious correspondence with you according to our promise to each other before we parted...When I first moved here it was my intention to visit your country soon; but after forming an acquaintance here; and getting established in business, I became much better satisfied than at first. I have had good employ in teaching for three years in succession in this place...I have been very unfortunate in the way of property. I have lost several pretty good horses since I came here, and it has kept me so behind in the world, that my constant application to business has been necessary. I lost two very fine young horses this spring - with the bots(?) I suppose. So that I have had but very little opportunity of travelling since I have been living here. But if I live I intend to visit your country yet... I have been twice in Sequachie since I moved from there...my old classmates...Some of them stand firm and unshaken in the faith; while others of them have grown cold in religion and become too worldly minded...Brother Christians has moved to the western districk, or Forkeddeer country...My sister Mary is married and lives about twelve or thirteen miles from me... Yours in Christian love,"

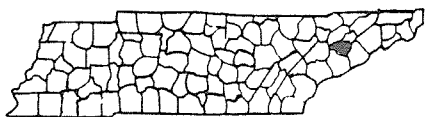

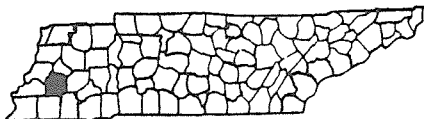

BOOK REVIEWS

A LOST HEROINE OF THE CONFEDERACY, The Diaries and Letters of Belle Edmondson edited by William and Loretta Galbraith. 1990. Paper back, 5x8. Indexed, 239 pp. Order from University Press of Mississippi, 3825 Ridgewood Rd., Jackson, MS 39211. \$15.95 (Hardback \$32.50)

How did the women of the South contribute to the Civil War effort? This question is answered as this poignant story unfolds from the pages of the letters and diaries of a 23 year old girl living with her widowed father just outside the Federal lines at Memphis, TN. While researching the history of the antebellum mansion Waverly in Columbus, Clay Co, MS, the editors became interested in Belle Edmondson "an elusive spy and smuggler extraordinaire...a dedicated Mata Hari for the Confederacy." They found her invitation to a masquerade ball in 1865 among the papers of the mansion. The value of the letters and diaries, which have survived, is greatly enhanced by the footnotes representing the Galbraith's extensive research into the people, places and battles mentioned. The action becomes more realistic by the inclusion of pictures of the Edmondson family.

STANDEFER/STANDIFER/STANDIFORD, A Family History and Genealogy by Harry Standefer. 1989. Soft back, 8½x11, 228 pp. Order from Ann Utterback, 5430 Baltimore Dr., #75, La Mesa, CA 92042. \$45.00

This 95 year old author introduces his family as one whose name, in one spelling or another, has been in existence over 1000 years. He dates the existence of the name in it's original spelling as Anglo-Saxon, dating from the incursion of these people into England in 499 A.D. Historical incidents are given in relation to generations of the family down to the present with some interesting stories of the various ancestors. He uses a widely separated margin on many pages which contain an ancestor's name and some historical events during his lifetime. Included are a number of sketches, photographs, original documents, and ancestor charts. An index in the standard form is not included, but the book has a listing of ancestor names, their generation number, date of birth and page listing of each. Mr. Standefer states that in his many years of research he has acquired 2500 pages of material on this one family.

IN SEARCH OF YOUR GERMAN ROOTS, A Complete Guide To Tracing Your Ancestors In The Germanic Areas of Europe by Angus Baxter. 1991. Soft back, 6x9. Indexed, 116 pp. Order from Genealogical Publishing Co., Inc., 1001 N. Calvert St., Baltimore, MD 21202. \$10.95 plus \$2.50 P&H

This book is a guide to help those of German ancestry whose families originated in the Germanic areas of Europe. The author explains that these areas are not confined to present day Germany, but are of many diverse areas of the continent where Germanic peoples have settled at various times in history. There is a brief history of German migrations through several centuries which includes those areas of the Americas where these people have settled at various times. A large number of organizations and sources in Germany, which contain church and official records, are listed, as are a number of German genealogical associations in North America (U.S. and Canada) and a bibliography.

ANGLO-AMERICANS IN SPANISH ARCHIVES, Lists of Anglo-American Settlers in the Spanish Colonies of America, A Finding Aid by Lawrence H Feldman. 1991. Hard back, 6x9. Full name Index, 349 pp. Order from Genealogical Publishing Co, Inc., 1001 N. Calvert St., Baltimore, MD 21202. \$30.00 plus \$2.50 P&H

The author gives a capsule history of the movement of Anglo-Americans into the Spanish claimed areas of America. There were many problems working in the Spanish Archives, especially Archivo General de Indias in Seville; also in Simancas, Segovia, and other Spanish repositories. The kinds of records held in these archives are extensive, including census, correspondence of officials, wills, sales of property, debts, partnerships, powers of attorney, etc. The book is arranged in columns in Tables designating name, place, date and type of record. The areas of North America specifically referred to are Mobile, Tombeche, Belize, Pensacola, Saint Augustine, Baton Rouge, Natchez, New Madrid, with broader areas in FL, LA, AR and MO.

WHAT'S IN A NAME? TENNESSEE TOWNS by Adrian W McClaren. 1991. Soft back, 8½x11, 47 pp. Order from: Compiler, 2485 Tarbet Dr., Memphis, TN 38119. \$5.00

Have you ever wondered how your town acquired its name? Is it named after a country, a

president, an Indian name, a Biblical name or just a Southern girls' name? The compiler of this small book on Tennessee towns gives us this information on a large number of communities. The original section of towns, listed in alphabetical order, is followed by Addendum 1 & 2. An additional section lists each county by formation date, giving the source of the name and the county seat.

MASSAC COUNTY, ILLINOIS EARLY MARRIAGE RECORDS, 1843-1877, Volume I by Carolyn Cromeenes Foss and Judy Foreman Lee. 1991. Soft back, 8½x11. Full name Index, 110 pp. Order from Judy Foreman Lee, 6688 Outer Gray St., Newburgh, IN 47630. \$17.00

Massac County, Illinois was established in 1843 from Johnson and Pope Counties. The name was taken from Fort Massac, a corruption of a French surname, Massiac. A county map with the township areas locates this county at the southern tip of Illinois. The marriage data was taken from microfilm of an old marriage book with no letter or number, plus Books A,B,C and 1 & 2. In addition, data is given from records found in the Courthouse but not on the film. The arrangement is in chronological order. In this early period the state asked only for basic information on the bride and groom, but in 1878 more detailed information was required.

THE LAWSON GOLDEN BOOK by Virginia Ruth Lawson Trent. 1990. Soft back, 8½x11. Full name Index, 206 pp. Order from author, 2115 Ogilby, Dubuque, IA 52001. \$25.00 plus \$2.00 P&H

The primary family is Lawson, but the book contains some detailed information on related families of Jones, Morgan, Pickering, Crooks, Coram, Robinson and Owens. The book includes a number of photographs of various family members with an occasional personal note about some of them. Generally the physical arrangement is in two columns with name, birth and marriage dates in the first column and additional information relating to place and to whom married in the second column. There is a depiction of a coat of arms of a Lawson and Morgan family.

WILLIAMSON COUNTY, TENNESSEE DEED ABSTRACTS, 1799-1811; Volume A, No. 1, Volume A-2 and Volume B by Joyce Martin Murray. 1991. Hard back, 6x9. Full name Index, 202 pp. Order from author, 2921 Daniel, Dallas, TX 75202. \$30.00

The area of Williamson Co was part of Davidson Co until it was formed in 1799. At that time Williamson included what later became Maury, Giles, part of Lawrence and Marshall Counties. The largest number of settlers came from North and South Carolina and Virginia, with a very large number coming from the ranks of the veterans of the American Revolution. The indentures give date, price of land, location of land and names of witnesses as well as the names of the parties buying and selling the land. Early deed record books often include Land Grants, power of attorney, an occasional will and deed of gifts which identify relationships. Many references to indentures that took place in the 1780s and 1790s occur.

REVOLUTIONARY WAR PERIOD BIBLE FAMILY & MARRIAGE RECORDS, Gleaned From Pension Applications, Index Vols. 1-10. 1990. Soft back, 5½x8½, 344 pp. \$25.00

REVOLUTIONARY WAR PERIOD BIBLE FAMILY & MARRIAGE RECORDS, Gleaned From Pension Applications, Vol. 11 by Chan Edmondson. 1991. Soft back, 5½x8½. Indexed, 145 pp. Order from author, P.O. Box 141235, Dallas, TX 75214-1235. \$15.00

The primary objective of this series is to abstract birth, marriage and death records from pension applications submitted by soldiers or their heirs. Eleven volumes of the series have been published to date. Each volume is arranged alphabetically by the soldier's surname and contains a full name index of all names abstracted from the soldier's file. Vol. 1 begins with soldiers named Aaron and continues through soldiers named Ausley. The index for this volume contains names from Aaron through Zimmerman within its 121 pages. Volume 11 covers soldiers named Eacker through Eyler; its index runs from Abbott to Zimmerman. The Cumulative Index of Vols. 1-10, a separate book, does not contain any abstracted data, but does contain about 50,000 names which occur in the first ten volumes. In many instances the widow of a soldier, in order to prove her eligibility for a pension or county lands, furnished her family Bible records as well as marriage licenses, deed titles and other information. All of this is preserved in the soldier's file.

MONTGOMERY COUNTY, GEORGIA GENEALOGICAL SOURCE MATERIAL by James E Dorsey. 1991. Soft back, 6x9. Full name Index, 96 pp. Order from: Magnolia Press, P.O. Box 2921, Gainesville, GA 30503. \$14.95

The author states that he gathered the material in this book for another publication, but did not include it for lack of space. Therefore, the book contains a combination of various genealogical materials of Montgomery County. There are twenty-two separate listings in the Table of Contents, among them are Estray Marks and Brands, 1807-1837; Sales and Division of Estates; School Records, 1884-1889; County Deed Book, 1841-1845; Registry of Physicians and Dentists, 1881-1909; Insolvent Tax List, 1824-1826; Muster Roll, 1862; Military Records; Tatt-nall County Militia Officers, 1800-1810. This is not a complete list of the miscellaneous records included, but it shows the variety and scope of the data.

A WIREGRASS READER, NEWSPAPER ABSTRACTS FROM THE LATE NINETEENTH CENTURY by James E. Dorsey. 1991. Soft back, 6x9. Full name Index, 209 pp. Order from: Magnolia Press, P.O. Box 2921, Gainesville, GA 30503. \$20.00

Newspaper abstracts contained in this book were gleaned primarily from the Eastman Times during the 1880s, a time when the Wiregrass region of Georgia was experiencing a great deal of growth and prosperity. There are some entries from the Sandersville Mercury and Bullock Times. The counties featured are Montgomery, Laurens, Talfair, Dodge, Candler and Johnson. The subject matter covered is a variety from personal letters, court records, births, deaths and marriages. Some of the letters are most interesting as they give not only a wide selection of names of the area, but an inside look at the kind of life led by these people.

APPRENTICES OF VIRGINIA 1623-1800 BY Harold B. Gill, Jr. 1989. Soft back, 6x9. Full name index, 295 pp. Order from: Ancestry, P.O. Box 476, Salt Lake City, UT 84100. \$16.95 + \$4.00 P&H

The author delves into the practice of apprenticeship, which was inherited from England, and it's prevalence in America during the colonial period and into the nineteenth century. There are approximately 2000 entries in this book. Some Virginia counties have a large number of entries and others have none. Each entry includes the name of the apprentice, the master, beginning and ending dates of apprenticeship if known, occupation of master, race of the apprentice, county of apprenticeship and source of the information. Occasionally a parent is named, or the apprentice's age is given. The author found some apprenticeship contracts in private papers and newspapers as well as the court records.

OUR SHELBY by Johnnie Mullinax Johnson. 1991. Hard back, 8½x11. Full name Index, 209 pp. Order from author, 405 Davis Dr., Athens, TX 75751. \$30.00

"Our Shelbys" is not a chronology but rather a history in story form. It traces the Shelby line from Essie Ruth Shelby back to Wales c1650 and Philip Selby (as was then spelled). Descendants of Rees and Mary Shelby who died in South Carolina are included. These descendants came to Maury, Montgomery, Rutherford, Hardin and other counties in Tennessee. The author is a Texas Shelby. Chapters in the book are built around Essie Ruth Shelby, William Ivey Shelby, Moses Kelly Shelby, Moses Shelby, Jonathan Shelby, Rees Shelby, Evan Shelby and Philip Shelby. Many illustrations are included, consisting of maps, documents and lineage charts. Written in narrative style it contains much anecdotal material which adds to the interest and value of the content. Associated families mentioned are Mullinax, Claxton, Warren, Cook, Martin, Petty, Beardin and many others.

SCOTT COUNTY, VIRGINIA DEATH RECORDS, 1853-1870 by Bernice Peters McKean. Soft back, 8½x11. Indexed, 47 pp. Order from compiler, 25571 Ryan Rd., Warren MI 48091. \$9.00

Scott County, Virginia is located in southwest Virginia bordering northeast Tennessee. The author states this record is very complete and she gives credit to the county clerks who copied the information given to them by the relatives of the deceased. This completeness is indicated by the following data in the death records: surname and first name of the deceased, date of death, age (year, day, month), place of death, cause of death, place of birth, parents name, spouse name, by whom reported, relationship to deceased, district of the county, and occasionally reference to subsidiary information. The book is arranged by the Death Date column.

THE PROMINENT FAMILIES OF THE UNITED STATES OF AMERICA edited by Arthur Meredyth Burke. 1991; Reprint of 1908. Hard back, 6x9. Full name Index, 510 pp. Order from: Genealogical Publishing Co., Inc., 1001 N. Calvert St., Baltimore, MD 21202-3897. \$35.00 plus \$2.50 P&H

In his preface the author gives a most convincing testimonial to his documentary authenticity. His sources include parish records, archives of public offices, family papers and many other reliable sources. Over 400 families are covered in this volume, giving descent from earliest ancestor and origins in Europe (usually from the British Isles) to recent family members. A 30-page index of other individuals forms a cross index to additional family connections. The introduction includes valuable historical background to explain the circumstances of the early settlers in terms of their social and economic conditions. It also discusses the political and religious imperatives of the 17th century which were two of the most important reasons for the migrations to America.

ENGLISH ORIGINS OF AMERICAN COLONISTS by Henry B. Hoff. 1991. Hard back, 5½x8½. Full name Index, 287 pp. Order from: Genealogical Publishing Co., Inc., 1001 N. Calvert St., Baltimore, MD 21202-3897. \$28.50 plus \$2.50 P&H

The original source for these records is English probate records and depositions. Thousands of pages of abstracts and transcriptions have been published in American periodicals over the years. Among the most important of these is The New York Genealogical and Biographical Record which published four series of these records, now collected and reprinted in this work. They consist of (1) "Clues from English Archives Contributory to American Genealogy"; (2) "New York Gleaning in England"; (3) "Genealogical Notes from the High Court of Admiralty Examinations"; and (4) "A Digest of Essex Wills with Particular Reference to Names of Importance in the American Colonies." This is more than a series of lists. Much associated data are included and many wills are narrations containing information with both family and historical value.

SEVENTEENTH CENTURY COLONIAL ANCESTORS compiled by Mary Louise M. Hutton. 1991 Reprint, Consolidated Edition. Hard back, 5½x8½, 467 pp. Order from: Genealogical Publishing Co., Inc., 1001 N. Calvert St., Baltimore, MD 21202-3897. \$30.00 plus \$2.50 P&H

Eight thousand members of the National Society Colonial Dames XVII Century have proven over 13,000 blood lines from colonial ancestors. Most entries give the name of the colonial ancestor, his dates of birth and death, the name of his wife, his Colony of residence, and his occupation or service. To the 1976 original list are added the two supplements, 1981 and 1988, both containing 2500 additional ancestors. Each section is alphabetical by the surname of the colonist. There is no index for other names. From 1915-1942 the colonial ancestor could have come or have been in one of the thirteen original colonies at any time in the colonial period, namely, to 1775. In 1942, this ruling was changed and since that time, the early settler must have been in one of the colonies before 1701. The names of the proven ancestors arriving after 1701 are separated into an Appendix.

LIVINGSTON COUNTY, KENTUCKY DEEDS, BOOKS A-C, 1800-1817, VOL. 1. 1991. Soft back, 8½x11. Full name Index, 141 pp. \$23.00; \$28.00 Hard back; IN residents add 5% tax

LIVINGSTON COUNTY, KENTUCKY DEEDS, BOOKS D-E, 1818-1822, VOL. 2 and MISCELLANEOUS LOOSE PAPERS by Brenda Joyce Jerome. 1991. Soft back, 8½x11. Full name Index, 148 pp. Order from author, 300 West Water St., Newburgh, IN 47630-1158. \$23.00; \$28.00 Hard back, IN residents add 5% tax

Livingston County is located along the Tennessee and Ohio Rivers in western Kentucky. It was formed in 1798/9 from Christian County and until 1809 included all of the present day counties of Caldwell, Crittenden, Livingston, Lyon and part of Trigg. Early settlers were often from Virginia, North and South Carolina by way of Tennessee. These books include not only deeds, but powers of attorney, bills of sale and divisions of estates. Some deeds reflect grants to Revolutionary War veterans, which were sometimes sold to others. Many deeds list owners since the original grant. The miscellaneous loose papers provide additional information such as: land claims, unrecorded deeds, complaints, depositions, road petitions, estate inventories, appraisals and sales. The compiler also used data from the first court order book and her own research to complete the information on that time periods. Besides the full name index there is a location index for mention of states and counties other than Livingston.

ALONG THE OLD STAGE-COACH ROAD, Morning Sun and Brunswick, Shelby County, Tennessee by Ellen Davies-Rodgers. 1990. Hard back, 6x9. Full name Index, 308 pp. Order from: The Plantation Press, Davies Plantation, Brunswick, TN 38014. \$30.00

This volume is both an interesting history of Shelby County and a valuable collection of genealogical data. It tells us of early Indian tribes and trails which later became today's roads and streets. Accounts and pictures of both early and contemporary citizens are given, as well as pictures of homes and churches. One chapter covers the Morning Sun and Pleasant Hill cemeteries, listing interments in alphabetical order, and another chapter is up-to-date describing the Brunswick Homecoming 1986. Excellent genealogical material is included in the chapter giving the origins of road names. Since Mrs. Rodgers' ancestors were early settlers of this area, much of the information is concerned with Davies Plantation, its history and environs.

POPE COUNTY ILLINOIS MARRIAGE BOOKS A-E, 1813-1877, VOLUME I. 1990. Soft back, 8½x11. Full name Index, 216 pp. \$29.00

POPE COUNTY ILLINOIS MARRIAGE REGISTER A-1, 1878-1888, VOLUME II both by Judy Foreman Lee and Carolyn Cromeenes Foss. 1991. Soft back, 8½x11. Full name Index, 130 pp. Order from Judy Foreman Lee, 6688 Outer Gray St., Newburgh, IN 47630. \$29.00

Although Pope County was established from Gallatin and Johnson Counties in 1816, the compilers found some marriage records in the front of Book "A", leading to the assumption of an earlier marriage book. The information in Volume I is set up in four columns with groom, bride, official and title, and date. If there was no return, it was so indicated. There are occasionally explanatory notes following the marriage records, usually Consents. A county map is included. Volume II is a continuation of Pope County Marriages, Volume I. An explanatory note by the Pope County Court Clerk explains that up to 1878 only basic information on the bride and groom was required to obtain a marriage license, but beginning in 1878 the following information was required: name and ages of bride and groom, residence, place of birth, names of parents, race or color, number of times married, occupation of groom, location and date of marriage, witnesses and officiant.

ORANGE COUNTY, NORTH CAROLINA TAXPAYERS, 1784-1793 by T.L.C. Genealogy. 1991. Soft back, 9x11, 97 pp. Order from: TLC Genealogy, Box 403369, Miami Beach, FL 33140-1369. \$12.00

The names of 7,792 taxpayers who owned property and paid taxes in Orange County between the years 1784 and 1793 are listed in alphabetical order in this book. According to the heading of one tax list, these lists include "inhabitants and others." Therefore, some of the names will be non-residents, although who they were is not listed as such. All taxpayers are listed by district or residence and date. In some cases additional information is included, such as widow, orphan, guardian, son of, etc.

GENEALOGICAL CLASSIFICATION BY FAMILY GROUP CODING FOR DESCENT FROM COMMON ANCESTORS, Volume I and Volume II by Cameron Ralph Stewart. 1986. Hard back, 6x9. Volume I 1028 pp; Volume II 860 pp plus 363 pp Index. Order from author: P O Box 3011, Long Beach, CA 90803. \$189.00 (set)

Ten ancestral families have been used to emphasize Mr. Stewart's unique method of classification. The family names are: Stewart, McAlester-McMaster, Sarles, Sharrard, Bentl(e)y, Shippee, Badgerow, Gjer(d)e-Trodo(-Traa), Miltzow, Osmundatter-Knutson. Basically, the author used the first two letters of each surname in his classification and follows with a series of letter designations relating to individuals in each of these families. Each line of each family is indicated by a Roman numeral. This is one of the most extensively documented family-oriented histories in print. The detail is overwhelming, and the families listed are followed not only in America, but into early Europe as well. Numerous ancestral coats-of-arms, maps, portraits and photographs from Norway, Scotland, Canada and the United States help to make the names and numbers become individual personalities.

CERTIFICATE OF TENNESSEE ANCESTRY

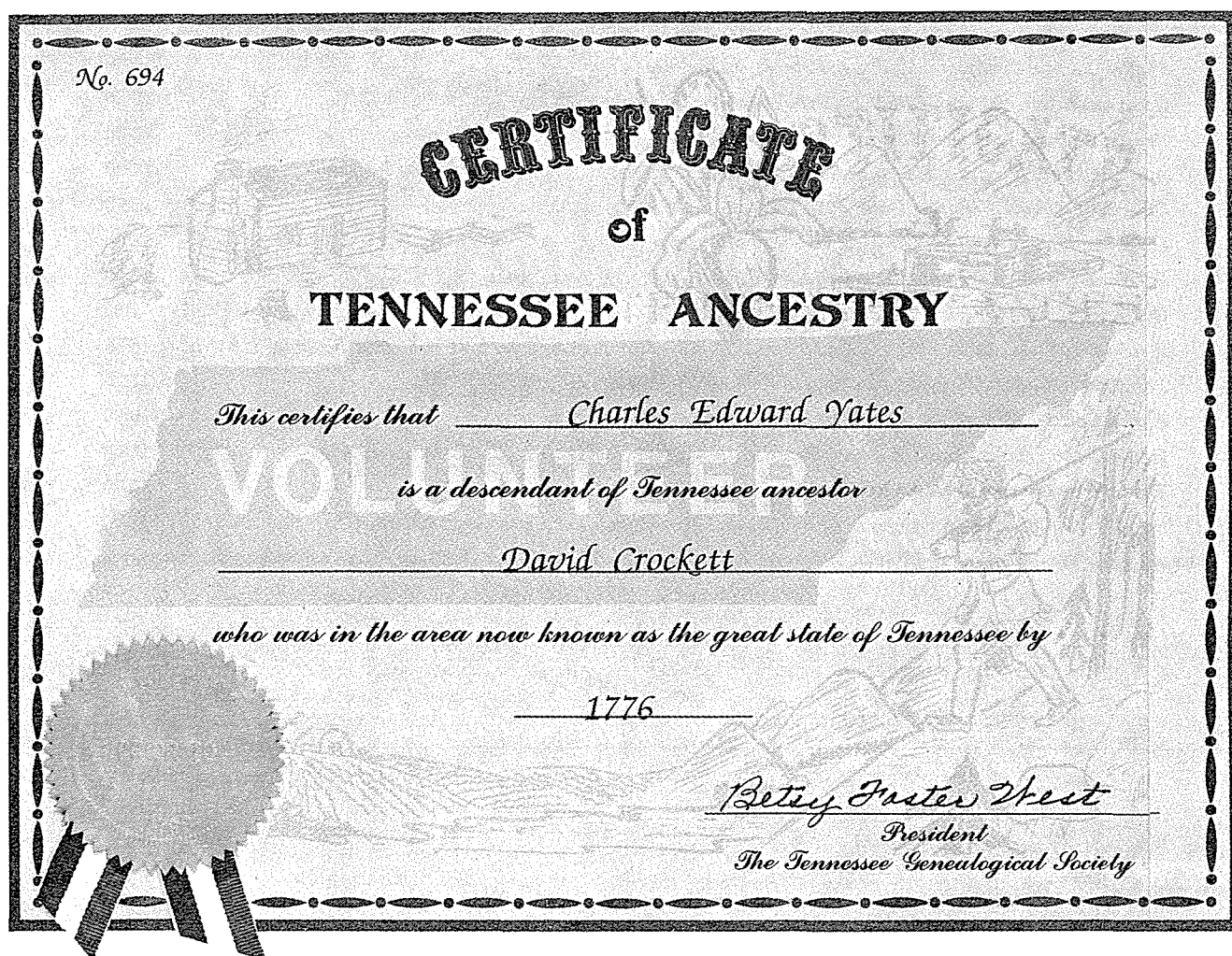
In 1986 The Tennessee Genealogical Society began a program to recognize descendants of our state's earliest settlers and to preserve their history. We have received records on many Tennessee founders; publication of this material is planned. If you have an ancestor who lived in Tennessee from early settlement through 1880, you are eligible to participate in the Certificate Program. It is not necessary for you to be a member of The Tennessee Genealogical Society, and you do not need to live in Tennessee. You are only required to have an ancestor who lived in Tennessee. There are three categories:

Prior to Statehood (1796): Pioneer—Certificate of Tennessee Ancestry

1797 to 1860: Settler—Certificate of Tennessee Ancestry

1861 to 1880: Certificate of Tennessee Ancestry

Shown below is a reduced copy of the certificate. The 8.5 x 11 inch original is printed on ivory parchment with background illustrations in gray half-tone. Printing is black highlighted by a gilt border. A shiny gold seal decorates the Settler certificate with a ribbon added for the Pioneer certificate.
