


#### Tennessee Ancestry Certificates Program Overview




#### Colonial-prior to 1 June 1796 Key Dates and Events

- 1763: Britain takes control of French land east of the Mississippi after the French & Indian War. King George forbids settlement.
- 1768: Permanent white settlement begins along Watauga River (William Bean of Virginia).
- 1775: Upper East Tennessee became Washington District, North Carolina.
- 1776 1781: Revolutionary War.
  - 1780: Battle of Kings Mountain

#### Colonial-prior to 1 June 1796 Key Dates and Events con't

- 1779: Fort Nashborough established.
- 1784: State of Franklin (only till 1788).
- 1789: North Carolina ceded it's claim to the Federal government, reserving the right to issue Revolutionary War Bounty Land.
- 1790: Congress created the "Territory South of the Ohio River", aka the Southwest Territory, capital at Knoxville.
- 1791: The Knoxville Gazette became Tennessee's first newspaper.




#### US Territorial Map 1790

#### Colonial-prior to 1 June 1796 Genealogical Resources

- The record you are looking for may be in North Carolina.
  - Or someone born before 1796 in North Carolina, might have been born in present day Tennessee.
- 1790 Census of the Southwest Territory lost
  - Substitutes available
- Revolutionary War
  - Revolutionary War Pension Records
  - DAR and SAR records
  - Revolutionary War Bounty Land
    - Patriot Paths at TSLA
- Land Records



#### Colonial-prior to 1 June 1796 Genealogical Resources

- Tax Lists potentially place an ancestor in a certain county at a certain time.
  - Earliest Washington County, NC 1778
- Draper Manuscripts
- Vital Records
  - Don't exist, except for Marriage Records in some counties.
  - Look for Bible Records, Cemetery Records, Newspapers, etc. for birth, death and marriage information.
  - Various published extracts from newspapers, court records, etc.



#### Territorial-prior to 15 June 1836 Key Dates and Events

- 1812: *The Tennessean* begins publication.
- War of 1812.
- 1818: US purchased land between the Tennessee River and the Mississippi River from the Chickasaw.
- 1835: Act creating civil districts within counties for the purpose of electing Justices of the Peace and Constables.
- 1836: Counties began sending tax lists to the state.



#### Territorial-prior to 15 June 1836 Genealogy Resources

- Census
  - 1800 Census Lost.
  - 1810 Census Only Grainger and Rutherford Counties survive.
    - Substitutes
  - 1820 Census Only 26 counties from the Western (Nashville) district survive.
  - 1830 Census heads of households.
- War of 1812 Military Records



#### Territorial-prior to 15 June 1836 Genealogy Resources

- Draper Manuscripts
- Tax Lists
- Land Records
- Vital Records
  - Still don't exist, except for Marriage Records in some counties.
  - Look for Bible Records, Cemetery Records, Newspapers, etc. for birth, death and marriage information.
  - Various published extracts from newspapers, court records, etc.



#### Antebellum-prior to 6 May 1861 Key Dates and Events

- 1837-1838: Trail of Tears.
- 1838: Counties were required to keep marriage records in bound books.
- 1859: Final survey of boundary between Kentucky and Tennessee. For people who lived near the border, records may be in either state.



#### Antebellum-prior to 6 May 1861 Genealogical Resources

- Census
  - 1840 Census heads of households.
  - 1850 Census lists everyone in household, but no relationships identified.
    - Mortality schedules
    - Slave schedules
  - 1860 Census enumerators given printed instructions.
    - Mortality schedules
    - Slave schedules
- City Directories start being published.
  - Memphis (earliest 1849)
  - Nashville (earliest 1853/54)
  - Knoxville (earliest 1859)



#### Antebellum-prior to 6 May 1861 Genealogical Resources

- Vital Records
  - County Marriage Records more common.
  - State Birth and Death records still don't exist.
  - Look for Bible Records, Cemetery Records, Newspapers, etc. for birth, death and marriage information.
  - Various published extracts from newspapers, court records, etc.
- Tax Lists



#### Civil War(1861-1865) Key Dates and Events

- 1861: Tennessee is the last of the southern states to secede from the Union.
- 1865: Formation of the Freedman's Bureau.
- 1866: Tennessee is the first state readmitted to the Union.



#### Civil War(1861-1865) Genealogical Records

- Compiled Service Records
  - Union Soldiers
  - Confederate Soldiers
- Confederate Pension Applications
- Confederate Widow Pension Applications
- Tennessee Civil War Veterans Questionnaires



#### Nineteenth Century-prior to 31 Dec 1900 Key Dates

- 1865 1872: Freedman's Bureau.
- 1878: Yellow Fever Epidemic.
- 1883: Ida B. Wells challenges "separate but equal" railroad laws.
- 1896: Shiloh National Military Park created.
- 1897: Tennessee Centennial and International Exposition in Nashville.



#### Nineteenth Century-prior to 31 Dec 1900 Genealogical Records

- Census
  - 1870 Census
  - 1880 Census provides relationships
    - Mortality schedules
  - 1890 Census most records LOST
    - 1890 Special Census of Union Civil War Veterans
  - 1900 Census lots of details including birth month & year; years married; for women, # children & # children living.
- 1891 Enumeration of Male Voters



#### Nineteenth Century-prior to 31 Dec 1900 Genealogical Records

- City Directories are even more common.
  - Chattanooga (earliest 1871/72)
- Local Histories and Vanity Biographies
  - Formation of many county and state historical societies.
  - Goodspeed's History of Tennessee.



#### Twentieth Century Key Dates

- 1908: Birth (released after 100 years) and Death Records (released after 50 years) statewide, except 1913. Spotty early adoption.
- World War I
- 1929: Great Depression
- 1933: Tennessee Valley Authority formed.
- 1935: Social Security began.
- World War II
- 1945: Statewide Registration of Marriages (released after 50 years).



#### Twentieth Century Genealogical Resources

- Census
  - 1910 Census
  - 1920 Census
  - 1930 Census
  - 1940 Census Identifies person providing information
  - 1950 Census COMING SOON (April 2022)
- Great Depression
  - WPA put people to work transcribing many records.
- Military Records
- Vital Records
  - Delayed Certificates of Birth (to apply for Social Security).
